On 01/08/07, Jonathan Ethier, 25 of #11 Cedar Street in Portland, ME was charged with Operating with a Suspended Registration pursuant to a motor vehicle violation observed on the Alfred Road. Ethier is scheduled to appear at Biddeford District Court on 3/2/07.

On 01/11/07, Lewis Fink III, 44 of #9 Curtis Lake Drive in Sanford, ME was charged with Failing to Register a Motor Vehicle pursuant to a motor vehicle violation observed on the Webber Hill Road. Fink is scheduled to appear at Biddeford District Court on 4/25/07.

On 01/11/07, Benjamin Fitzpatrick, 19 of #4 Jeffreys Way in Kennebunk was arrested and charged with Violating Conditions of Release pursuant to police observing Fitzpatrick on Beach Avenue. Fitzpatrick was found to be in possession of alcohol which is a violation of his conditions of release from a prior arrest. Fitzpatrick was transported to the York County Jail and is scheduled to appear at Biddeford District Court on 4/25/07.

On 01/12/07, a 16 year-old Kennebunk juvenile was charged with Criminal Mischief pursuant to a complaint from Dunkin Donuts reporting that the juvenile threw a pen into a piece of their equipment, damaging it. Damage amount is unknown at press time and the juvenile is scheduled to appear at Biddeford District Court on 3/22/07.

On 01/13/07, a 17 year-old Kennebunk juvenile was charged with Eluding a Police Officer and Criminal Speed pursuant to police observing the juvenile's vehicle traveling 68 MPH in a 35 MPH speed zone on the Alfred Road. Police turned to initiate a traffic stop and located the vehicle off the road involved in a collision in the area of 421 Alfred Road. There were only minor injuries reported but the 1999 Ford Taurus sustained approximately \$8,000.00 in damage. The juvenile is scheduled to appear at Biddeford District Court on 3/22/07.

On 01/15/07, Gregory Holder, 33 of #12 Matthew Lane in Kennebunk was charged with Operating Under the Influence of Alcohol pursuant to a motor vehicle accident he was involved in on the Webber Hill Road in the area of the blueberry plains. Holder was not seriously injured in the accident but his 2006 Nissan Titan sustained approximately \$20,000.00 in damage. Holder is scheduled to appear at Biddeford District Court on 4/25/07.

On 01/15/07, Steven Savage, 40 of #72 Blossom Street in Lowell, MA was arrested and charged with Operating Under the Influence of alcohol and Possession of a Usable Amount of Marijuana pursuant to an off-duty Kennebunk Police Sergeant reporting he was run off the road by a vehicle on York Street. Savage was released after bail was posted and he is scheduled to appear at Biddeford District Court on 4/25/07.
